Dear Sir,

I am directed to inform you that selection of Indian Archery teams for following international competitions will be held at SAI Eastern Centre, Kolkata from 11<sup>th</sup> to 14<sup>th</sup> May, 2011 (Arrival-10<sup>th</sup> May/Departure - 15<sup>th</sup> May) :-

- i) **Youth World Chmapionship - Legnica (Poland) from 22<sup>nd</sup> to 28<sup>th</sup> August, 2011**  
Junior Recurve Boys & Girls; Junior Compound Boys ; Cadet Recurve Boys & Girls; Cadet Compound Boys & Girls (3 members in each category). It may be noted that Junior Compound Girls' Team will not participate in the Youth World.
- ii) **2<sup>nd</sup> Stage World Cup - Antalya (Turkey) from 6-11 June, 2011**  
Recurve Men & Women; Compound Men & Women (4 members in each category)
- iii) **World Outdoor Target Championship - Torino (Italy) from 3-10 July, 2011**  
Recurve Men and Women; Compound Men and Women (3 members in each category)
- iv) **3<sup>rd</sup> Asian Grand Prix Archery Championship - Bangladesh from 25-31 May, 2011**  
Junior Recurve Boys and Girls and Senior Compound Men and Women (4 members in each category)

The Selection process will be as under :-

### **Eligibility for participation**

#### **A) Junior and Sub-Junior/Cadet :**

- i) Top 08 archers in 7 categories considering the results of qualification round and elimination round in the 33<sup>rd</sup> Junior National - Delhi and 31<sup>st</sup> Sub-Junior National-Dhanbad have been selected for the Youth Selection Trials. List of eligible archers are attached herewith.
- ii) Any archer who has failed to attend the Junior and Sub-Junior National but represented India in any of the Junior and Cadet/Youth World Championship are also eligible for participating in the trials subject to fulfillment of following age criteria :-
  - In case of Junior - An archer who born on 1<sup>st</sup> January, 1991 or later
  - In case of Sub-Junior/Cadet-An archer who born on 1<sup>st</sup> January, 1994 or later
- iii) Please ensure that those Archers who have already got Identity Card issued by the AAI must bring the same during the trials. In case of non-issuance, an authentic and valid birth certificate of age issued by Municipal Corporation, School Principal, Gram Panchayat will have to be produced at the venue of the trial failing which archers will have to undergo a

medical examination. Any archer found overage will be disqualified for all future National Championships and Selection Trials.

- iv) It has been observed that a few Junior archers are entitled to participate in Cadet class events due to age and some Cadet arches have caliber to shoot in Junior class keeping in view his/her shooting skill. All participating archers are required to submit his/her choice of participation either in Junior class or Cadet class category at least 15 days prior to the Selection Trials to Archery Association of India. Archery Association of India shall be the final Authority to decide in the interest of Archery and the country as well.

**B) Senior :**

32 archers (8 in each category) selected as Campers for World Championship considering the results of Selection trial held at Kolkata from 26<sup>th</sup> to 29<sup>th</sup> March, 2011 will be eligible to attend the trials.

**Selection procedure**

**A) Junior and Sub-Junior/Cadet**

Junior Recurve Boys - Double FITA Round (288 Arrows) in 90, 70, 50 & 30 Mtrs.,distances  
Junior Recurve Girls - Double FITA Round (288 Arrows) in 70, 60, 50 & 30 Mtrs.,distances  
Junior Compound Boys - Double FITA Round (288 Arrows) in 90, 70, 50 & 30 Mtrs.,distances  
Cadet Recurve and Compound Boys - Double FITA Round (288 Arrows) in 70, 60, 50 & 30 Mtrs.  
Cadet Recurve and Compound Girls - Double FITA Round (288 Arrows) in 60, 50, 40 & 30 Mtrs.

**B) Senior**

Senior Recurve Men & Women - Double FITA Round (288 Arrows)  
Senior Compound Men & Women - 288 Arrows will be shot in 50 mtrs on 6 Ring Target Face

You are requested to kindly circulate this notice to all concerned immediately and send the name/s of eligible archers for the selection trial along with their choice of class (Junior or Cadet) to Archery Association of India through mail at [indian.archery@yahoo.in](mailto:indian.archery@yahoo.in) or at [sreerupa@cal2.vsnl.net.in](mailto:sreerupa@cal2.vsnl.net.in).

It may be conveyed to eligible archers that authentic age proof, valid passport, passport size photographs (3) with white background, may please be carried while attending the trial.
