The General Council of Archery Association of India has allotted the "3rd Mini (13 years and under) Indian Round, Recurve and Compound Divisions National Archery Championship" to Andhra Pradesh Archery Association. The event will be conducted at Vijayawada (Andhra Pradesh) from 27th to 31st August, 2010 (inclusive of arrival and departure days) with the active alliance of Vijayawada Distt. Archery Association and Volga Archery Academy. Competition may leave in the evening of 30th August.

Age Eligibility : The age group both boys and girls will be 13 years and under. Kindly ensure that archers who attend the Mini National are born on or after 1997. Secretaries of all affiliated Unit are requested to ensure that Archers must carry valid documentary age evidence/proof with him/her during the National failing which the archer will not be allowed to participate.

Entry : Each State Association/Unit may enter a maximum of 4 men and 4 women archers per category (Recurve, Compound & Indian Round). No individual or additional entry is allowed.

Boarding & Lodging - Free boarding & lodging facilities would be provided to all the participants during the period of event . It may be noted that no individual or additional entry shall be entertained.
