Subject: Selection of Junior Team for Asia Cup 3rd Stage – Chinese Taipei

Dear Sir/Madam

This is with reference to AAI circular No.AAI/Unit/Sel.Trial/AC/2018 dated 21st May, 2018 regarding Junior Selection Trial to be held at SAI, NBA Rohtak on 9th& 10th June, 2018 for the Asia Cup 3rd Stage-Chinese Taipei.

Though the Asia Cups are not age-restricted events, it has now become a standard practice of the Association to send Junior Archers for all the stages of the Asia Cups. Asia Cups are being projected as competition exposure for Junior Archers in the Annual Calendar of Training and Competition (ACTC) being submitted annually to Sports Authority of India. According to age rules, an Archer may be considered a Junior up to and in the year of his/her 20th birthday. As such, an Archer who is born in 1998 and thereafter, should be considered as eligible for the Asia Cup-2018.

In view of the Junior and Sub-Junior National Championships-2017 not yet having been conducted, and based on the ACTC for the financial year 2017-18, Archers born in 1997 and thereafter, took part in the selection trials held on 19-20 February, 2018 for Bangkok-Asia Cup Stage-1 and Manila-Asia Cup Stage-2. From this trial top 16 Archers in each category were shortlisted for the ensuing selection trial for Asia Cup Stage-3.

Taking into consideration the ACTC for the year 2018-19, and after due deliberations with the Sports Authority of India, it has now been decided that Archers born in 1998 and thereafter would only be entitled for the ensuing Junior Selection Trial. Thus, a fresh list of eligible Archers (attached) has been drawn, eliminating Archers born before 1998. The earlier list of eligible Archers issued vide letter dated 21st May, 2018 may be ignored.

Apart from above, it has further been decided that the Archers who could not attend the Junior Selection Trial in February 2018 owing to their examinations or any other valid reason, but fulfill the eligibility criteria in terms of benchmark score (RM-640; RW-600; CM-675 & CW-645) in any of the recognized tournament as mentioned in the AAI letter dated 8th February, 2018 and who are born in 1998 and thereafter, may also be considered for participation in the trials, on production of relevant documents no later than 5th June, 2018.

The contents of this notice may kindly be brought to the notice of all concerned so as to ensure the participation of eligible archers.
