We are pleased to inform you that the 39th NTPC Senior Recurve, 15th Compound & 26th Indian Round National (M & W) Archery Championships-2018 will be held at Barabati Stadium, Cuttack, Odisha from 9-18 March, 2019 (both arrival and departure days are inclusive) under the aegis of Odisha Archery Association.

All the stakeholders are requested to go through the following instructions carefully for your own convenience and to ensure smooth and successful conduct of the above competitions.

I) Competition fixture, Arrival/Departure of Teams

Senior National will be conducted in three phases as per below mentioned programme:-

Compound (M & W)	13 th & 14 th Mar.,2019	12 th Mar. after 2 pm	14 th Mar(even)/15 th Mar (before noon)
Indian Round (M & W)	16 th & 17 th March 2019	15 th Mar. after 2 pm	17 th Mar(even)/18 th Mar (before noon)

All participating teams are requested to follow the arrival and departure schedule strictly in order to avoid any inconvenience to participants of the subsequent event. Teams reaching Cuttack before arrival day or leaving from Cuttack after departure day are requested to make their own arrangements.

Tentative Competition Schedule given is attached at Appendix "A".

II) Participation

Each participating member unit is eligible to field one team of maximum four men and one team of maximum four women archers in each of the category (Recurve, Compound, Indian Round) in National Championship. No individual or additional entry is allowed in the National Championship. Maximum one manager, one male coach and one female coach are allowed with the team.

III) Registration of Entry/Deadline/Penalty

- i) Entry of participating State Association/Associate Members for Senior National Championships would be accepted only through online registration. Entries must reach the AAI, no later than 1st March, 2019.
- ii) Entries received after the deadline, but by 6th March, 2019 will result in a Late Entry Penalty Fee of Rs.2,000/- per member per category. After 6th March, 2019 no entry would be entertained by AAI for the Junior National Championship. Member Associations / Units who are late entrants will have to intimate AAI in writing, accepting the relevant penalty clause, in order for their teams / members entry to be considered. The Late Entry Penalty Fee can be paid either through RTGS in AAI bank account before the event or upon arrival at the competition venue to the representative of AAI. Any member Association / Unit that has Penalty Fee outstanding will need to have paid the same in full before being eligible to participate.

IV) Accommodation and Food

- i) Free lodging and boarding facility will be provided to the admissible participants of the State/Associate Member as specified above in clause 'II' (Participation) of this letter.
- ii) The Organisers will not be responsible for additional Coaches, Manager and Parents etc.

V) Reception

All the participating teams will be received from Railway Station/Bus Terminal, if arrival intimation is received by the OC well in time.

VI) Flag

Flag of each participating member State Associations/Associate Members will be hoisted in the competition field and one will be required for March Past. Therefore, all teams are required to carry two sets of standard size flags (6 ft X 4 ft) while leaving their destinations for Cuttack.

VII) Selection of Probable

To select Indian teams for World Championship-2019 and World Cups-2019, top sixteen (16) Recurve and Compound (Men & Women) Archers based on the results of Senior Selection Trials held at SAI, Rohtak from 25-28 January 2019 and Eight (8) Recurve and Compound Archers (M&W) Senior National Archery Championship-Cuttack will compete in the Selection Trial at Cuttack just after the conclusion of the Recurve and Compound events respectively during the Senior National. for. Detailed information, in this regard will be communicated shortly.
