I am directed to inform you that Archery Association of India has decided to shortlist top 16 Senior Archers as probable in each category (Recurve Men, Recurve Women, Compound Men and Compound Women) for ensuing World Championship-2019 & World Cups-2019 through Open Selection Trial to be held at **SAI, NBA Rohak (Haryana)**. Details of the selection trial are given below :-

**i) Arrival/Departure of Participants**

Selection trials would be held as per below mentioned programme:-

Event	Arrival	Competition	Departure
Recurve (M & W)	24 <sup>th</sup> January, 2019	25-29 January, 2019	30 <sup>th</sup> January, 2019
Compound (M & W)	25 <sup>th</sup> January, 2019	26-29 January, 2019	30 <sup>th</sup> January, 2019

**ii) Benchmark Scores**

Eligibility Criteria for Selection Trial will be as follow:-

Event	Men	Women
Recurve	650	620
Compound	685	665

Archers who have scored equal or above the points mentioned in any National Championship/National Selection Trials/National Ranking Archery Tournament (NRAT)/State or Unit Championship/Selection Trials, Inter- University Championship in last 2 years are eligible to take part in trial.

In case of State or Unit Championship/Selection Trial and Inter-University Championship, it is obligatory to submit verification of benchmark scores, duly signed by President/Secretary/competent official of member State/Unit/concerned university.

Free hospitality including stay (in dormitory) and three meals will be provided to all the participating Archers. Efforts would be made to accommodate coaches in the SAI hostel. In case of any emergency, accompanying coaches will have to make boarding and lodging arrangements outside at their own cost.

All eligible Recurve Archers are advised to report on 24<sup>th</sup> January, 2019 and Compound Archers on 25<sup>th</sup> January 2019 at SAI NBA, Rohtak.

Please ensure that entry, by name of eligible and willing participants should reach on or before **20<sup>th</sup> January, 2019** at [indian.archery@yahoo.in](mailto:indian.archery@yahoo.in). Entry received after the deadline will not be entertained. The Final competition format will be circulated upon closing of entries.
